A MOTION WAS MADE BY JIMMY ATTEBURY AND $2^{\rm ND}$ BY PETE DOW TO ACCEPT THE FINANCIALS AS READ. ALL WERE IN FAVOR NONE OPPOSED.

FINANCIAL COMMITTEE: REPORT WAS GIVEN OUT FOR THE LAST 6 MONTHS WHICH WAS 7-1-2012 TO 12-31-12 AND ALL OF THE YEAR 2012. MAYOR JACK FIELDS WILL POST THE REPORT IN THE LOCAL NEWSPAPER.
