MINUTES FROM THE 111TH TOWN COUNCIL MEETING THIS WAS HELD ON
OCTOBER 7th, 2013.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS. MEMBERS
PRESENT WERE FRANK PFENENGER, JIMMY ATTEBURY, PETE DOW, TOMMY
QUALLS AND JAMES DRIVER MR. JOHN HOWARD AND MEMBERS OF THE
COMMUNITY WERE ALSO PRESENT.

A MOTION WAS MADE BY JIMMY ATTEBURY AND 2ND BY PETE DOW TO ACCEPT
THE MINUTES AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY PETE DOW
AND 2ND BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN. ALL WERE IN
FAVOR NONE OPPOSED

FINANCIAL COMMITTEE: NONE

ROAD COMMITTEE: MOWING IN TOWN WAS DONE.

ANNEX COMMITTEE: MR. HOWARD INFORMED THE BOARD THAT JUDGE WRIGHT
APPROVED THE ANNEXATION. MR. HOWARD IS WORKING ON THE PETITION. THE
BOARD HAS TO ADOPT A MEASURE ACCEPTING THE LANDS INTO THE TOWNS
AND HE WILL DRAFT A DOCUMENT FOR THE NEXT TOWN MEETING. THERE IS A
30 DAY APPEAL WINDOW IF THE OPPOSITION SO CHOOSES TO FILE. A MOTION
WAS MADE BY TOMMY QUALLS AND 2ND BY PETE DOW NOT TO TRY AND
COLLECT REIMBURSEMENT ON ADDITIONAL COST OF ANNEXATION FOR THE
TOWN. ALL WERE IN FAVOR NONE OPPOSED.

OLD BUSINESS: WEB PAGE IS STILL BEING WORKED ON BY KELLY SYSTEMS.


NEW BUSINESS: MAYOR JACK FIELDS PRESENTED BIDS FOR PAVING OF MUNGLE

MOTION WAS MADE BY TOMMY QUALLS TO ACCEPT BIDS AND 2ND BY JIMMY
ATTEBURY ALL WERE IN FAVOR NONE OPPOSED.

MAYOR JACK FIELDS REQUESTED \$25,000 DOLLARS BE MOVED FROM GENERAL
FUND TO THE STREET FUND TO COVER PAVING. A MOTION WAS MADE BY JAMES
DRIVER AND 2ND BY JIMMY ATTEBURY TO MOVE THE SAID FUNDS. ALL WERE IN
FAVOR NONE OPPOSED.

MAYOR JACK FIELDS PRESENTED A BID FROM TIM JACKSON FOR DIRT WORK TO
BE DONE ON LAND. THE BOARD REQUESTED HIM TO GET MORE BIDS BY
RUNNING AN ADD IN THE PAPER FOR 2 WEEKS.

MR. HOWARD PRESENTED THE BOARD WITH TWO DRAFTS FOR THE ORDINANCE REGARDING ELECTED OFFICIALS AND EMPLOYEES CONDUCTING BUSINESS WITH THE CITY. A MOTION WAS MADE BY TOMMY QUALLS AND 2ND BY PETE DOW TO ACCEPT THE 2ND DRAFT WITH NO RETRO DATE. ALL WERE IN FAVOR NONE OPPOSED.

A MOTION WAS MADE BY JIMMY ATTEBURY AND 2ND BY PETE DOW TO ADJOURN. ALL WERE IN FAVOR NONE OPPOSED.
