MINUTES FROM THE 113<sup>TH</sup> TOWN COUNCIL MEETING THIS WAS HELD ON  
DECEMBER 9, 2013.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS. MEMBERS  
PRESENT WERE JIMMY ATTEBURY, TOMMY QUALLS, JAMES DRIVER AND FRANK  
PFENENGER. MEMBER ABSENT WAS PETE DOW. MR. JOHN HOWARD WAS ALSO  
PRESENT.

A MOTION WAS MADE BY TOMMY QUALLS AND 2<sup>ND</sup> BY JAMES DRIVER TO  
ACCEPT THE MINUTES AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY JAMES  
DRIVER AND 2<sup>ND</sup> BY FRANK PFENENGER TO ACCEPT THEM AS WRITTEN. ALL  
WERE IN FAVOR NONE OPPOSED

FINANCIAL COMMITTEE: NONE

ROAD COMMITTEE: PAVING IS DONE ON STAGECOACH, MUNGAL AND  
GOOSEPOND ROADS. SOME SANDING WAS DONE ON CITY ROADS DUE TO WINTER  
STORM.

AN ORDINANCE TO AMEND ORDINANCE 2013-001 AND TO PROVIDE FOR A  
AMENDED 2013 BUDGET. FOR THE CITY OF FOUNTAIN LAKE, ARKANSAS, FOR THE  
TWELVE (12) MONTHS BEGINNING JANUARY 1, 2013 AND ENDING DECEMBER 31,  
2013 WAS READ FOR THE 2<sup>ND</sup> TIME. A MOTION TO WAIVE THE RULES OF THE 3<sup>RD</sup>  
READING FOR NEXT MONTH AND READ AGAIN TONIGHT AND VOTE ON WAS  
MADE BY TOMMY QUALLS AND 2<sup>ND</sup> BY JIMMY ATTEBURY IT WAS READ AGAIN  
FOR THE 3<sup>RD</sup> TIME. ALL WERE IN FAVOR NONE OPPOSED.

MR JOHN HOWARD READ AN ORDINANCE PERMITTING ELECTED OFFICIALS AND  
EMPLOYEES TO CONDUCT BUSINESS WITH THE TOWN OF FOUNTAIN LAKE FOR  
THE 2<sup>ND</sup> TIME.

A ORDINANCE PROVIDING FOR AND ADOPTING FOR THE TOWN OF FOUNTAIN  
LAKE, ARKANASAS FOR THE TWELVE (12) MONTHS BEGINNING JANUARY 1, 2014  
AND ENDING DECEMBER 31, 2014; APPROPRIATING MONEY FOR EACH AND EVERY  
ITEM OF EXPENDITURE THEREIN PROVIDED FOR; AND OTHER PURPOSES WAS  
READ FOR THE 2<sup>ND</sup> TIME.

NEW BUSINESS: MR. JOHN HOWARD PRESENTED AN ORDINANCE APPROVING  
ANNEXATION UP TO DANVILLE ROAD. A MOTION WAS MADE BY JIMMY  
ATTEBURY AND 2<sup>ND</sup> BY JAMES DRIVER FOR ORDINANCE TO BE READ FOR THE  
FIRST READING ALL WERE IN FAVOR NONE OPPOSED. MR. JOHN HOWARD READ  
THE ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE  
TOWN OF FOUNTAIN LAKE, ARKANSAS AND MAKING THE SAME PART OF  
FOUNTAIN LAKE, ARKANSAS.

A MOTION TO ADJOURN WAS MADE BY FRANK PFENENGER AND 2<sup>ND</sup> BY JAMES
