JANUARY 13, 2014.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS. MEMBERS
PRESENT WERE JIMMY ATTEBURY, TOMMY QUALLS, JAMES DRIVER AND FRANK
PFENENGER. MEMBER ABSENT WAS PETE DOW. MR. JOHN HOWARD WAS ALSO
PRESENT.

A MOTION WAS MADE BY FRANK PFENENGER AND 2ND BY TOMMY QUALLS TO
ACCEPT THE MINUTES AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY TOMMY
QUALLS AND 2ND BY FRANK PFENENGER TO ACCEPT THEM AS WRITTEN. ALL
WERE IN FAVOR NONE OPPOSED


OLD BUSINESS: WEB SITE DONE- ORDINANCE PERMITTING ELECTED OFFICIALS
AND EMPLOYEES TO CONDUCT BUSINESS WITH THE TOWN OF FOUNTAIN LAKE
WAS READ FOR THE 3RD TIME A MOTION WAS MADE BY TOMMY QUALLS AND 2ND
BY JAMES DRIVER ALL WERE IN FAVOR NONE OPPOSED.-ORDINANCE FOR THE
2014 BUDGET WAS READ FOR THE 3RD TIME A MOTION WAS MADE BY FRANK
PFENENGER AND 2ND BY JIMMY ATTEBURY. ALL WERE IN FAVOR NONE OPPOSED.
THE ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE
TOWN OF FOUNTAIN LAKE, ARKANSAS AND MAKING SAME A PART OF THE TOWN
OF FOUNTAIN LAKE, ARKANSAS WAS READ FOR THE 2ND TIME. A MOTION WAS
MADE BY TOMMY QUALLS AND 2ND BY JIMMY ATTEBURY ALL WERE IN FAVOR
NONE OPPOSED.

NEW BUSINESS: MAYOR JACK FIELDS PRESENTED THE DOCUMENT TO THE CITY
ABOUT THE AGREEMENT BETWEEN HOT SPRINGS AND THE TOWN WHICH
BASICALLY SHOWED APPROVAL AND SUPPORT OF THE NEW JAIL. THEY ARE
NOW REQUESTING THE TAXES THAT HAVE BEEN COLLECTED TO BE TURNED
OVER AND THE DOCUMENT SIGNED BY THE MAYOR. MR. JOHN HOWARD STATED
AT THE TIME OF THE DRAFT BACK IN 2011 THE CITY HAD A POLICE STATION AND
IN THIS DRAFT IT TALKED ABOUT THE PRISONERS WHICH THE TOWN MIGHT
HAVE TAKEN TO THE NEW JAIL. THE TOWN NO LONGER HAS A POLICE
DEPARTMENT SO WE WILL NOT HAVE PRISONERS. MR. HOWARD STATES THAT
THERE IS A NEED FOR CLARIFICATION OF HOW THE TOWN IS GOING TO BENEFIT

FROM THIS AND WHAT ROLE AND RESPONSIBILITY. MAYOR JACK FIELDS ASKED
MR. HOWARD TO CONTACT JUDGE DAVIS FOR A CORRECTION LETTER.

A MOTION WAS MADE BY TOMMY QUALLS AND 2ND BY JIMMY ATTEBURY TO
TURN THE TAXES COLLECTED OVER AFTER THE CORRECTION LETTER IS MADE
AND SIGNED BY THE MAYOR. ALL WERE IN FAVOR NONE OPPOSED.

A MOTION TO ADJOURN WAS MADE BY TOMMY QUALLS AND 2ND BY JIMMY
ATTEBURY. ALL WERE IN FAVOR NONE OPPOSED.
