MINUTES FROM THE 116<sup>TH</sup> TOWN COUNCIL MEETING THIS WAS HELD ON MARCH 24, 2014.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS. MEMBERS PRESENT WERE JIMMY ATTEBURY, TOMMY QUALLS AND FRANK PFENENGER. MEMBERS ABSENT WERE PETE DOW AND JAMES DRIVER. MR. JOHN HOWARD WAS ALSO PRESENT.

A MOTION WAS MADE BY FRANK PFENENGER AND 2<sup>ND</sup> BY JIMMY ATTEBURY TO ACCEPT THE MINUTES AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY JIMMY ATTEBURY AND 2<sup>ND</sup> BY TOMMY QUALLS TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED

FINANCIAL COMMITTEE: NONE

ROAD COMMITTEE: CLEANING OUT DITCHES ON CITY ROADS.

OLD BUSINESS: MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD BIDS FOR THE DRIVEWAY AND FOUNDATION PAD FOR THE TOWN HALL. THE BID FROM RICKY ECHOLS DOZER EXCAVATING WAS \$4,600.00. THE BID FROM TIM JACKSON EXCAVATING WAS \$3270.00. THE BID FROM GREG COVEY CONSTRUCTION WAS \$7950.00. THE BID FROM RICK'S BACKHOE & DOZIER SVC WAS \$7250.00. A MOTION WAS MADE BY TOMMY QUALLS TO ACCEPT THE CHEAPEST BID AND 2<sup>ND</sup> BY JIMMY ATTEBURY. ALL WERE IN FAVOR NONE OPPOSED FOR TIM JACKSON EXCAVATING TO DO THE WORK.

MR. JOHN HOWARD SPOKE TO THE COUNTY JUDGE AND ATTORNEY ABOUT THE CONTRACT FOR THE JAIL MONEY. THEY BOTH AGREED TO THE REDRAFT OF THE DOCUMENT WITH THE NEEDED CHANGES. MR. HOWARD WILL BRING THE REDRAFTED DOCUMENT TO THE NEXT MEETING.

NEW BUSINESS: MAYOR JACK FIELDS WILL PUT A REQUEST IN THE NEWSPAPER FOR PAVING AND CHIP AND SEAL OF SOME CITY ROADS.

MAYOR JACK FIELDS INFORMED THE BOARD THAT THE CITY LIMIT SIGN WAS MOVED TO THE NEW LOCATION.
