MEMBERS ABSENT WERE PETE DOW AND FRANK PFENENGER. ATTORNEY
JOHN HOWARD WAS ALSO PRESENT.

A MOTION WAS MADE BY JIMMY ATTEBURY AND 2ND BY JAMES DRIVER TO
ACCEPT THE MINUTES AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY
JIMMY ATTEBURY AND 2ND BY JAMES DRIVER TO ACCEPT THEM AS
WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

FINANCIAL COMMITTEE: NONE


ROAD COMMITTEE: MAYOR JACK FIELDS INFORMED THE BOARD A
CULVERT NEEDS TO BE FIXED ON GOOSE POND ROAD AND A LIGHT WILL
BE PUT IN AT HILLVALE AND HWY 5 AS SOON AS RIGHT AWAY IS GIVEN.

OLD BUSINESS: JOHN HOWARD TALKED TO THE BOARD ABOUT
BECOMING A CITY OF 2ND CLASS AND WILL BRING REQUIREMENTS TO
FUTURE MEETING.

THE TOWN OF FOUNTAIN LAKE WILL GET WIFI AND A SCANNER SO IT
WILL BE ABLE TO POST DOCUMENTS TO THE TOWN WEB SITE.

NEW BUSINESS: MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD THE
FINDINGS FROM THE AUDIT FOR THE YEARS 2013 & 2014. THE
RECORDER/TREASURER WAS IN SUBSTANTIAL COMPLIANCE WITH
ARKANSAS FISCAL AND FINANCIAL LAW. NONCOMPLIANCE WITH STATE
LAW AND ACCEPTED ACCOUNTING PRACTICES WAS NOTED IN THE OFFICE
OF MAYOR. THE GENERAL FUND WAS EXCEEDED BY 33% IN
NONCOMPLIANCE WITH ARK CODE ANN 14-58-203. MAYOR JACK FIELDS
INFORMED THE BOARD THAT HE WROTE AN APOLOGY LETTER
INFORMING THE LEGISLATIVE AUDIT COMMITTEE THAT WE WILL TAKE
STEPS TO MAKE SURE THAT DOESN'T HAPPEN IN THE FUTURE. BOARD
MEMBERS SHOULD OF RECEIVED A COPY OF THE AUDIT FINDINGS.

A MOTION WAS MADE BY TOMMY QUALLS AND 2ND BY JIMMY ATTEBURY
TO ADJOURN. ALL WERE IN FAVOR NONE OPPOSED.
