FINANCIAL REPORT WAS GIVEN A MOTION WAS MADE BY JIMMY ATTEBURY AND $2^{\rm ND}$ BY TOMMY QUALLS TO ACCEPT THE FINANCIALS ALL WERE IN FAVOR NONE OPPOSED.

FINANCIAL COMMITTEE: NO REPORT GIVEN

ROAD COMMITTEE: MOWING WILL START THIS WEEK. MT PINES MOWER AND OPERATOR WILL BE USED.
CULVERT ON HILLVALE WILL BE FIXED BY VILLAGE LANDSCAPE AND CULVERTS ON TOWN ROADS WILL BE CLEANED OUT BY THEM ALSO.

ANNEX COMMITTEE: THE ANNEX PAPERS WERE TURNED IN AND JUDGE DAVIS WILL SET A DATE WHICH IS SUPPOSED TO BE DONE WITHIN 30 DAYS. THE TOWN HAD 61% OF POPULATION THAT WANTS TO BE ANNEXED. MR. CARL RADER BROUGHT UP DISCUSSION ABOUT THE COUNTY TAX THAT IS TRYING TO BE PASSED FOR THE NEW JAIL AND THAT THE CITY SHOULD MAKE CLEAR THAT THE TOWN OF FOUNTAIN LAKE IS NOT CREATING THIS TAX.

ORDINANCE COMMITTEE: THE ORDINANCE TO REGULATE UNSANITARY, UNSIGHTLY CONDITIONS ON REAL PROPERTY WAS PRESENTED TO THE BOARD.

A MOTION TO SUPPORT THE RESOLUTION OF A GARLAND COUNTY WIDE SALES AND USE TAX TO PAY THE COSTS OF OPERATING AND MAINTAINING DETENTION FACILITIES AND THE COST OF HOUSING PRISONERS COMMENCING ON APRIL 1, 2013 WAS MADE BY TOMMY QUALLS AND $2^{\rm ND}$ BY JIMMY ATTEBURY. FRANK PHENENGER VOTED FOR AND CARL RADER VOTED AGAINST.

A MOTION WAS MADE BY FRANK PHENENGER FOR THE RESOLUTION TO EXPRESS THE WILLINGNESS OF THE TOWN TO ASSIST IN THE DIVISION OF THE GARLAND COUNTY DISTRICT COURT AND TO MAKE A PAYMENT OF \$2,192.40 AS PAYMENT FOR THE OPERATING EXPENSE OF FOUNTAIN LAKE DIVISION OF THE DISTRICT COURT FOR A PERIOD OF 9-1-11 THROUGH 12-31-2011. IT WAS 2ND BY JIMMY ATTEBURY. TOMMY QUALLS WAS FOR AND CARL RADER WAS AGAINST.

MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD ABOUT HOW MUCH THE TOWN HAS SPENT IN THE PAST YEARS FOR MOWING AND WEED EATING THE TOWN ROADS. HE SAID IT MAY BE IN THE CITIES BEST INTEREST TO LOOK INTO PURCHASING A MOWER IN THE NEXT YEAR OR SO.
