A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THE MINUTES AS WRITTEN AND IT WAS $2^{\rm ND}$ BY JAMES DRIVER. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY JAMES DRIVER AND $2^{\rm ND}$ BY JIMMY ATTEBRURY TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

ROAD COMMITTEE: CLEANING DITCHES ON HILLVALE AND NEEDHAM.

OLD BUSINESS: MR. TOM QUALLS DISCUSSED THE BIDS WE HAD FOR THE SECURITY SYSTEM FOR THE TOWN HALL WITH 60% DOWN PAYMENT AND THE REMAINING BALANCE WHEN SYSTEM IS PUT IN AND WORKING. A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THE BID FROM ICU PROTECTION LLC AND IT WAS 2^{ND} BY JAMES DRIVER. ALL WERE IN FAVOR. NONE OPPOSED.

DISCUSSION WAS MADE ABOUT THE FIRE STATION BUYING BACK THE ACRE BEHIND THEM FOR \$4,000.00 DOLLARS. THE TOWN HAS SPENT \$9,250.00 ON SAID ACRE. THE TOWN WILL MAKE A COUNTER OFFER OF \$7,000.00. A MOTION WAS MADE BY JIMMY ATTEBURY TO MAKE COUNTER OFFER AND IT WAS 2^{ND} BY JAMES DRIVER. JIMMY ATTEBURY AND JAMES DRIVER WERE FOR THE MOTION KARL LOWRY WAS AGAINST. MOTION PASSED 2 TO 1. MAYOR JACK FIELDS WILL CALL THE MUNICPAL LEAGUE CONCERNING ACCEPTING A LOWER AMOUNT FOR LAND.

NEW BUSINESS: MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD 3 BIDS FOR WINDOWS AND SIDING FROM WILSONS, HANKE BROTHERS AND TAYLOR SIDING. DISCUSSION WAS MADE BY BOARD AND A MOTION WAS MADE TO ACCEPT THE

CHEAPEST BID WHICH WAS FROM TAYLOR SIDING FROM JIMMY ATTEBURY AND 2ND BY JAMES DRIVER. ALL WERE IN FAVOR NONE OPPOSED.

THE CLERK/TREASURER TRACIE TAYLOR BROUGHT BEFORE THE BOARD THAT SHE HAD ACCIDENTLY PAID THE TOWN WATER BILL WITH HER PERSONAL CHECKING ACCT. SHE IS ASKING TO BE REIMBURSED FOR THE AMOUNT SHE PAID BY MISTAKE WHICH WAS \$60.00. SHE CALLED THE WATER COMPANY AND WAS TOLD THERE WAS NOTHING THEY COULD DO AND THE TOWN WOULD HAVE TO REIMBURSE ME. SHE SENT A NEW CHECK FOR THE TOWN AMOUNT. A MOTION WAS MADE BY JIMMY ATTEBURY AND 2ND BY JAMES DRIVER TO REIMBURSE THE TOWN CLERK TRACIE TAYLOR FOR THE PAYMENT. ALL WERE IN FAVOR NONE OPPOSED.
