ROAD COMMITTEE: GOING TO MOW TOWN ROADS ONE MORE TIME.



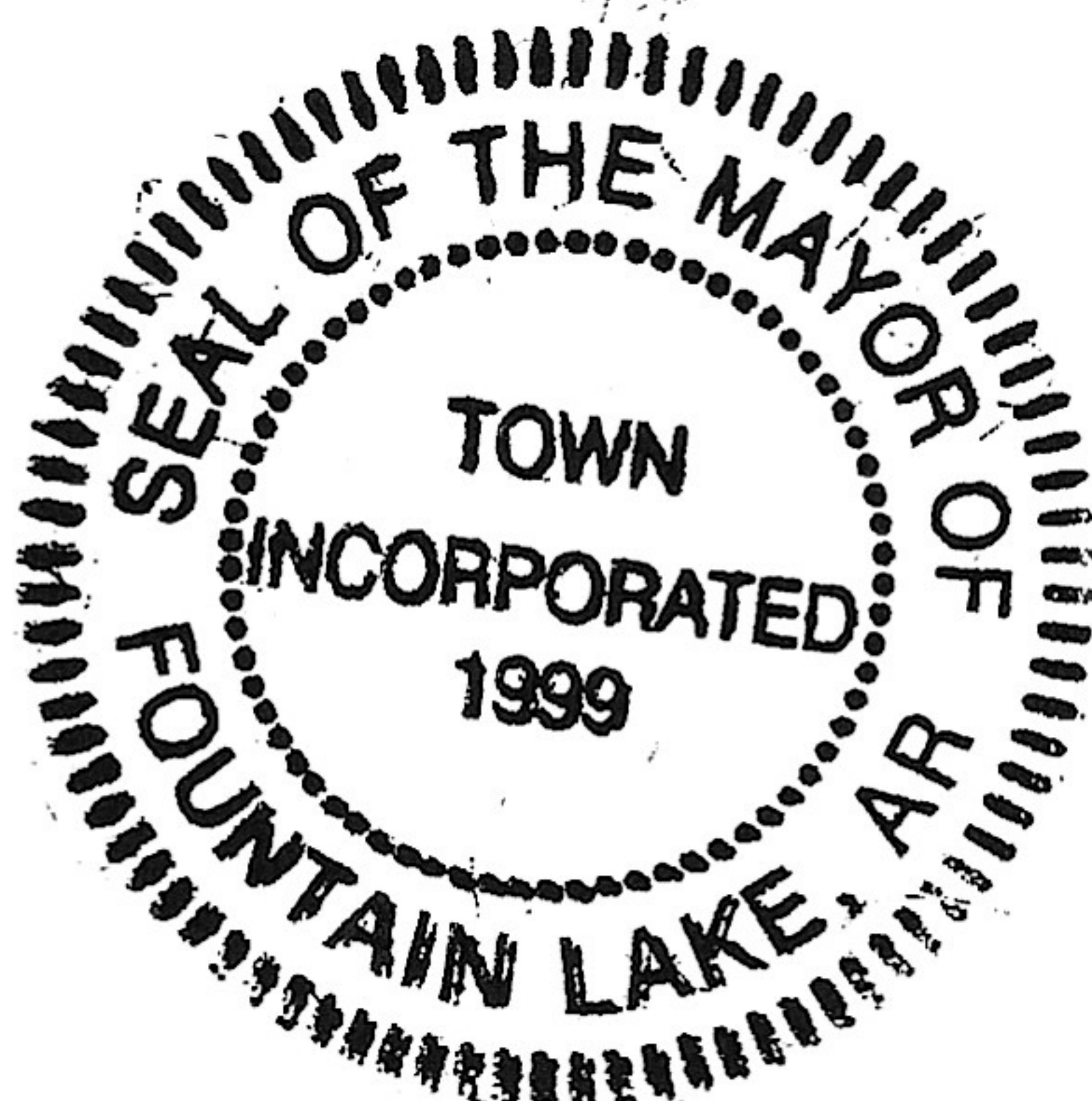


NEW BUSINESS: TOWN HAS RECEIVED BIDS FOR ROAD WORK.
