THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS

MEMBERS PRESENT WERE JIMMY ATTEBURY, KARL LOWRY AND JAMES DRIVER.  
MEMBERS ABSENT WERE JOHN MINTON AND RICK QUALLS.

A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THE MINUTES AS  
WRITTEN AND IT WAS 2<sup>ND</sup> BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN AND A MOTION WAS MADE BY JIMMY  
ATTEBRURY AND 2<sup>ND</sup> BY KARL LOWRY TO ACCEPT THEM AS WRITTEN. ALL WERE IN  
FAVOR NONE OPPOSED.

BUYING THE ACRE BACK. TRACIE TAYLOR SAID THAT SHE HADNT HEARD FROM  
THE FIRE DEPARTMENT BUT WOULD GIVE THEM A CALL AND GET BACK TO THE  
BOARD.

ASSET ORDINANCE WAS READ FOR THE 2<sup>ND</sup> TIME.

NEW BUSINESS: MAYOR JACK FIELDS INFORMED THE BOARD THAT TIM JACKSON  
PUT OUT SAND ON SOME OF THE TOWN ROADS DUE TO WINTER STORM.

MAYOR JACK FIELDS INFORMED THE BOARD THAT THE COUNTY WILL BE  
REAPPRAISING.
