ANNEXATION COMMITTEE: DISCUSSION WAS MADE ABOUT COLLECTING SIGNATURES FOR ANNEXATION.


ROAD COMMITTEE: THE COUNCIL DISCUSSED SOME WORK THAT NEEDED TO BE DONE ON TOWN ROADS.

OLD BUSINESS: NONE



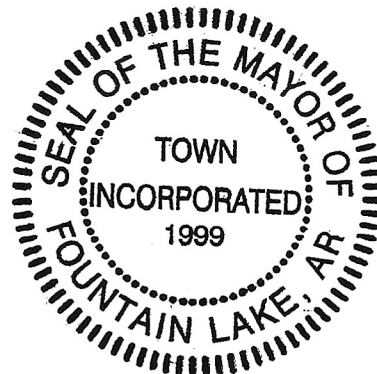
