MINUTES FROM THE 175TH TOWN COUNCIL MEETING. THIS WAS HELD ON JULY 29, 2019.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS.

MEMBERS PRESENT WERE MAYOR JACK FIELDS, JIMMY ATTEBURY, KARL LOWRY, JAMES DRIVER AND ED JONES. MEMBER ABSENT WAS RICK QUALLS. FIRE CHIEF MR. SAWYER AND JODI KEENER WAS ALSO PRESENT.

THE MINUTES WERE HANDED OUT AND A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN AND IT WAS 2<sup>ND</sup> BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT AND A MOTION WAS MADE BY KARL LOWRY AND 2<sup>ND</sup> BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.


NEW BUSINESS: DISCUSSION WAS MADE ABOUT MAKING CENTERHILL & MEDLOCK STREETS PART OF THE TOWN STREETS THAT ARE TAKEN CARE OF. A MOTION WAS MADE BY KARL LOWRY AND 2<sup>ND</sup> BY JIMMY ATTEBURY TO ACCEPT THE TWO STREETS AS CITY STREETS. ALL WERE IN FAVOR NONE OPPOSED.

KARL LOWRY HANDED OUT A REPORT ABOUT THE BLOCK PARTY WITH INFORMATION ABOUT WHAT THINGS WE DID RIGHT AND THINGS THAT THE TOWN COULD DO BETTER FOR NEXT YEAR. HE ESTIMATED THAT WE HAD ANYWHERE TO 100-150 PEOPLE ATTEND. WE DONATED THE LEFT OVER FOOD TO JACKSON HOUSE.



MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD ABOUT HIRING JODIE HILL KEENER AS THE ATTORNEY FOR THE TOWN OF FOUNTAIN LAKE AT A MINIMUM OF 3 HOURS FOR \$300.00 A MONTH AND \$175.00 AN HOUR FOR EXTENDED SERVICES WITH A CONTRACT TO BE BROUGHT TO THE NEXT MEETING. A MOTION WAS MADE BY JAMES DRIVER AND 2<sup>ND</sup> BY JIMMY ATTEBURY TO ACCEPT JODIE HILL KEENER AS THE ATTORNEY FOR THE TOWN OF FOUNTAIN LAKE STARTING IN AUGUST 2019. ALL WERE IN FAVOR NONE OPPOSED.
