THE MINUTES WERE HANDED OUT A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN AND IT WAS  $2^{ND}$  BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT AND A MOTION WAS MADE BY KARL LOWRY AND  $2^{ND}$  BY ED JONES TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.
