MINUTES FROM THE 178TH TOWN COUNCIL MEETING. THIS WAS HELD ON OCTOBER 14, 2019.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS.

MEMBERS PRESENT WERE MAYOR JACK FIELDS, JIMMY ATTEBURY, KARL LOWRY AND ED JONES. MEMBERS ABSENT WERE RICK QUALLS AND JAMES DRIVER, JODI KEENER WAS ALSO PRESENT.

THE MINUTES WERE HANDED OUT A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN AND IT WAS 2ND BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT AND A MOTION WAS MADE BY KARL LOWRY AND 2ND BY ED JONES TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.


OLD BUSINESS: NONE

NEW BUSINESS: MAYOR JACK FIELDS HANDED OUT THE BUDGET FOR THE YEAR 2020. THE BOARD LOOKED OVER THE BUDGET AND ORDINANCE #2019-01 (AN ORDINANCE PROVIDING FOR AND ADOPTING FOR THE TOWN OF FOUNTAIN LAKE, ARKANSAS FOR THE TWELVE MONTHS BEGINNING JANUARY 1, 2020 AND ENDING DECEMBER 31, 2020; APPROPRIATING MONEY FOR EACH AND EVERY ITEM OF EXPENDITURE THEREIN PROVIDED FOR; AND OTHER PURPOSES) WAS READ ONCE.

MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD RESOLUTION #2019-01 (A RESOLUTION LEVYING ZERO MILLS OF AD VALOREM TAXES FOR THE TOWN OF FOUNTAIN LAKE, ARKANSAS FOR THE YEAR 2020). IT WAS READ ONCE AND KARL LOWRY MADE A MOTION TO ACCEPT RESOLUTION # 2019-01 AND IT WAS 2ND BY ED JONES. ALL WERE IN FAVOR NONE OPPOSED.

KARL LOWRY BROUGHT BEFORE THE BOARD ABOUT THE TOWN HAVING A REPRESENTATIVE AT THE FOUNTAIN LAKE SCHOOL TRUNK OR TREAT EVENT. MAYOR JACK FIELDS AND CLERK TRACIE TAYLOR SAID THEY WOULD DONATE CANDY AND TRY TO HELP AT THE EVENT. KARL LOWRY SAID HE WOULD REPRESENT THE TOWN.

A MOTION WAS MADE BY JIMMY ATTEBURY TO ADJOURN AND IT WAS 2ND BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.
