THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN AND IT WAS 2ND BY ED JONES. ALL WERE IN FAVOR NONE OPPOSED.

CLERK/TREASURER SUGGESTED SIDEWALK FROM BACK DOOR TO FRONTDOOR FROM PARKING AREA AND ED JONES SUGGESTED PAVED PARKING AREA.


MAYOR JACK FIELDS WILL CHECK ON SIDEWALK AND PARKING PAD.
