MINUTES FROM THE 185TH TOWN COUNCIL MEETING. THIS WAS HELD ON SEPTEMBER 14, 2020.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS.

DUE TO COVID-19 THERE WERE NO MEETINGS IN JULY OR AUGUST.

MEMBERS PRESENT WERE MAYOR JACK FIELDS, JIMMY ATTEBURY, KARL LOWRY AND JAMES DRIVER. MEMBER ABSENT WAS ED JONES, ATTORNEY JODIE KEENER WAS PRESENT AND A BOY SCOUT REPRESENTATIVE WAS IN ATTENDANCE.

THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN AND IT WAS 2ND BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT FOR JUNE, JULY AND AUGUST 2020. A MOTION WAS MADE BY KARL LOWRY AND 2<sup>ND</sup> BY JIMMY ATTEBURY TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.

FINANCIAL COMMITTEE: 6 MONTH FINANCIAL REPORT WAS HANDED OUT AND MAYOR JACK FIELDS PUT IT IN THE PAPER. THE CLERK TREASURER INFORMED THE BOARD THAT SHE PAID THE TOWN HALL ELECTRIC BILL OUT OF THE STREET FUND BUT SHE MOVED THE FUNDS FROM THE GENERAL ACCOUNT BACK INTO THE STREET FUND. MAYOR JACK FIELDS USED THE TOWN CREDIT CARD BY MISTAKE FOR \$54.74 FOR AN ITEM AND HE PAID THE TOWN BACK FOR SAID ITEM AND IT WAS PUT BACK INTO THE GENERAL FUND. THE MAYOR WILL START WORKING ON THE BUDGET FOR 2021.

ROAD COMMITTEE: TIM JACKSON MOWED AND MULCHED ALL OF THE TOWN ROADS.

OLD BUSINESS: CLERK/TREASURER TOLD THE BOARD ABOUT THE FURNATURE AND WALL FIXTURES PURCHASED FOR THE TOWN HALL AND WILL BE LOOKING FOR A FEW MORE ITEMS.

NEW BUSINESS: MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD RESOLUTION #2020-01. A RESOLUTION LEVYING ZERO MILLS OF AD VALOREM TAXES FOR THE TOWN OF FOUNTAIN LAKE, ARKANSAS FOR THE YEAR 2021. CLERK/TEASURER TRACIE TAYLOR READ RESOLUTION #2020-01 LEVYING ZERO MILLS FOR SAID YEAR 2021 TO THE BOARD ONCE. MAYOR JACK FIELDS ASKED THE BOARD IF THEY WANTED TO PASS SAID RESOLUTION. JAMES DRIVER MADE A MOTION TO ACCEPT RESOLUTION #2020-01 AND IT WAS 2<sup>ND</sup> BY KARL LOWRY. ALL WERE TN FAVOR NONE OPPOSED.

MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD THAT MR. DARYL RIGSBY WOULD LIKE THE ROADS IN THE SUB-DIVISION HE BUILT TO BE TAKEN IN BY THE TOWN. DISCUSSION WAS MADE AND THE BOARD SUGGESTED THAT MR. RIGSBY GET THE SURVEY FOR SAID ROADS AND PRESENT IT TO THE TOWN FOR CONSIDERATION.

A REPRESENTATIVE FOR THE BOY SCOUTS TROOP #3008 ATTENDED THE MEETING AND ASKED IF THEY COULD USE THE PROPERTY FOR A TRUNK AND TREAT ON OCT. 31, 2020 FROM 2 TO 5. SOMEONE FROM THE BOARD WILL BE AT THE TOWN HALL. A MOTION WAS MADE BY JIMMY ATTEBURY AND 2<sup>ND</sup> BY JAMES DRIVER TO LET THEM HAVE THE TRUNK A TREAT IN THE FIELD. ALL WERE IN FAVOR NONE OPPOSED.

A MOTION WAS MADE BY JIMMY ATTEBURY TO ADJOURN AND IT WAS 2<sup>ND</sup> BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.
