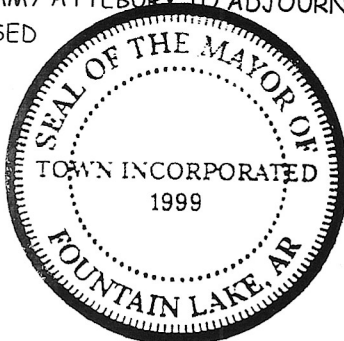



THE ORDINANCE TO AMEND ORDINANCE 2020-01 AND TO PROVIDE FOR AN AMENDED 2021 BUDGET FOR THE TOWN OF FOUNTAIN LAKE, AR. FOR THE TWELVE (12) MONTHS BEGINNING JANUARY 1, 2021 AND ENDING DECEMBER 31, 2021. DECLARING AN EMERGENCY TO EXIST AN FOR OTHER PURPOSES.
