THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS.

MEMBERS PRESENT WERE MAYOR JACK FIELDS, JIMMY ATTEBURY, KARL LOWRY AND NICK LOWRY.
ATTORNEY JODIE KEENER WAS ALSO PRESENT.

THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS
WRITTEN AND IT WAS 2ND BY NICK LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT. A MOTION WAS MADE BY KARL LOWRY AND 2ND BY JIMMY
ATTEBURY TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.

FINANCIAL COMMITTEE: WRONG CREDIT CARD WAS USED BY MAYOR JACK FIELDS FOR \$218.04 BUT HE

ROAD COMMITTEE: PAVING HAS ALMOST BEEN COMPLETED. GETTING BIDS FOR MEDLOCK & CENTER
HILL ROADS FOR ADDITIONAL PAVING.

OLD BUSINESS: ANNEXATION OF ELK MEADOWS SUB-DIVISION HAS BEEN FILED WITH THE COURT.
THE 2ND READING OF BUDGET ORDINANCE FOR 2023 WAS READ.


STILL WAITING FOR FUN GRANT NOTIFICATION OF YES OR NO FOR GRANT.

KARL LOWRY AND 2ND BY JIMMY ATTEBURY, ALL WERE IN FAVOR NONE OPPOSED.


THE MAYOR BROUGHT BEFORE THE BOARD A BID FOR PAVING CENTER HILL CHURCH ROAD FOR EST.
