THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY JIMMY ATTEBURY TO ACCEPT THEM AS  
WRITTEN AND IT WAS 2<sup>ND</sup> BY KARL LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE ROADS GET BAD.


OLD BUSINESS: ANNEXATION HEARING SET FOR 02/15/2023.

OF THE YEAR.


3RD AND FINAL READING OF THE ORDINANCE 2022-01 FOR THE 2023 BUDGET WAS READ. A MOTION  
WAS MADE BY JIMMY ATTEBURY TO ACCEPT THE 2023 ORDINANCE BUDGET AND IT WAS 2ND BY KARL  
LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

NEW BUSINESS: A MOTION WAS MADE BY JIMMY ATTEBURY AND 2<sup>ND</sup> BY KARL LOWRY DECLARING AN EMERGENCY  
TO EXIST AND TO WAIVE AND SUSPEND THE RULES AND FOR OTHER PURPOSES. THE ORDINANCE 2022-02 TO AMEND  
ORDINANCE 2021-01 FOR AN AMENDED BUDGET FOR 2022 WAS READ 3 TIMES BY CLERK/TREASURER TRACIE  
TAYLOR. A MOTION WAS MADE BY JIMMY ATTEBURY AND 2<sup>ND</sup> BY KARL LOWRY TO ACCEPT THE AMENDED BUDGET  
ORDINANCE. ALL WERE IN FAVOR NONE OPPOSED.
