

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FOUNTAIN LAKE, ARKANSAS, AN ORDINANCE TO BE ENTITLED:

**"AN ORDINANCE TO INCLUDE THE RESIDENTS OF THE CITY OF FOUNTAIN LAKE, ARKANSAS, INTO THE SOLID WASTE COLLECTION SYSTEM PREVIOUSLY ESTABLISHED BY GARLAND COUNTY, ARKANSAS, AND FOR OTHER PURPOSES"**

WHEREAS, Garland County, by and through its Quorum Court, has established a comprehensive house-to-house solid waste collection system as described in several Ordinances previously past by the Garland County Quorum Court;

WHEREAS, the residence of the City of Fountain Lake, would be excluded from the comprehensive Garland County Solid Waste Collection System;

WHEREAS, residents of the City of Fountain Lake, would be required to use various alternatives for the disposal of solid waste that is generated by households within the cooperate limits of the City;

WHEREAS, the City of Fountain Lake, by and through its City Counsel, has concluded it is in the best interest of the City of Fountain Lake, and its residents to participate in the comprehensive solid waste collection system previously established by Garland County; and

WHEREAS, the City of Fountain Lake, requests that the Quorum Court of Garland County, Arkansas, amend all Ordinances applicable to allow the area known as the City of Fountain Lake, to be included in the County's comprehensive solid waste collection system.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL FOR THE CITY OF FOUNTAIN LAKE, ARKANSAS

**SECTION I**

All persons and households residing within the City limits of the area known as the City of Fountain Lake, Arkansas, shall participate in the Garland County Comprehensive Solid Waste Collection System that has been previously established by Garland County, Arkansas.

**SECTION II**

All persons and households residing within the City limits of the City of Fountain Lake, Arkansas shall comply with all rules, regulations, ordinances, statutes, policy, procedures, and customs of the Garland County Solid Waste Collection System.

**SECTION III**

All persons and households residing within the City limits of the City of Fountain Lake shall be required to pay all fees established by the Quorum Court of Garland County, Arkansas, associated with the Comprehensive Solid Waste Collection System.

**SECTION IV**

A copy of all Garland County Ordinances, rules and regulations, policies or customs relating to the Solid Waste Collection System shall be available for public inspection at City Hall during all normal business hours.

**SECTION V:**

EMERGENCY CLAUSE: This ordinance being necessary to insure a timely continued collection and billing for solid waste services in the City of Fountain Lake, an emergency is hereby declared to exist and this ordinance shall be in effect thirty days after passage and approval by the City Council of Fountain Lake and after separate similar approval by The Garland County Quorum Court.
