

THE TOWN OF FOUNTAIN LAKE ORDINANCE NO 2019-06

AN ORDINANCE TO BE INCLUDED IN THE FOUNTAIN LAKE FIRE PROTECTION DISTRICT ESTABLISHED BY THE GARLAND COUNTY QUORUM COURT. DECLARING AN EMERGENCY TO EXIST AN FOR OTHER PURPOSES,

WHERE AS THE TOWN OF FOUNTAIN LAKE WISHES TO BE INCLUDED IN THE FOUNTAIN LAKE FIRE PROTECTION DISTRICT.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF FOUNTAIN LAKE, ARKANSAS:

SECTION 1. THE TOWN OF FOUNTAIN LAKE DOES NOT HAVE ITS OWN FIRE PROTECTION ASSOCIATION:

THE FOUNTAIN LAKE FIRE PROTECTION ASSOCIATION HAS PETITIONED THE GARLAND COUNTY QUORUM COURT TO CONVERT TO A FIRE PROTECTION DISTRICT PURSUANT TO ARK. CODE 14-284-226. SUCH CONVERSION WOULD RENDER THE TOWN OF FOUNTAIN LAKE WITHOUT FIRE PROTECTION SERVICES FOR ITS RESIDENTS.


SECTION 2. ADOPTING TO BE INCLUDED INTO THE FOUNTAIN LAKE FIRE PROTECTION DISTRICT:


THEREFORE, PURSUANT TO ARK. CODE 14-284-201 (a), THE TOWN OF FOUNTAIN LAKE HEREBY ADOPTS THIS ORDINANCE TO BE INCLUDED INTO THE FOUNTAIN LAKE FIRE PROTECTION DISTRICT AS ESTABLISHED BY THE GARLAND COUNTY QUORUM COURT.

SECTION 3. SEVERABILITY

SHOULD ANY SECTION, CLAUSE OR PHRASE OF THIS ORDINANCE BE DECLARED BY THE COURTS TO BE INVALID, THAT VALIDITY SHALL NOT AFFECT THE OTHER PROVISION OF THIS ORDINANCE WHICH SHALL BE GIVEN EFFECT WITHOUT THE INVALID PROVISION OR APPLICATION, AND TO THIS END, THE PROVISIONS OF THIS ORDINANCE ARE DECLARED TO BE SEVERABLE.
