RESOLUTION

WHEREAS, HOT SPRINGS VILLAGE PROPERTY OWNERS' ASSOCIATION (HSVPOA), a private community located on a portion of the boundary of the now incorporated Town of Fountain Lake, Arkansas, said private community having its own Public Works Department, utility systems, security and fire services, etc., and not being in need of any services or facilities of the town; and

WHEREAS, the incorporators of the Town of Fountain Lake, Arkansas never intended to include any of the lands within the boundaries of Hot Springs Village as a part of their municipality and such inclusion was inadvertent and mistaken; and

WHEREAS, Hot Springs Village Property Owners' Association has filed with this governing body a Petition requesting a Resolution from the Town Council abandoning and detaching certain described lands as set out in the legal descriptions submitted herein on Exhibit "A", together with plats of the location of said properties; and

WHEREAS, representatives of this council have verified that the lands requested to be detached are the property of Hot Springs Village Property Owners' Association or are lands located within the said private development; and

WHEREAS, there are no residents in the lands to be detached and abandoned and the lands are all on the boundary of the municipality;

NOW, THEREFORE, BE IT RESOLVED, BY THE TOWN COUNCIL OF THE TOWN OF FOUNTAIN LAKE, ARKANSAS:

That the boundary of the Town of Fountain Lake, Arkansas should be, and is hereby, modified to abandon and detach all lands reflected in the legal descriptions attached hereto and made a part hereof and noted as the "LESS AND EXCEPT" properties, said lands being lands owned by Hot Springs Village Property Owners' Association and/or located within said private community and which should not be within the boundaries of the Town of Fountain Lake, Arkansas;

Furthermore, that the newly described legal boundaries of the Town of Fountain Lake, Arkansas should be delivered to the Garland County Judge and said detachment and abandonment spread upon the records of said Garland County, Arkansas;

Furthermore, that the new legal boundaries of the Town of Fountain Lake, Arkansas should be delivered to the Arkansas Secretary of State and spread upon the records of the State of Arkansas;

Furthermore, that the newly elected and acting officials of the Town of Fountain Lake, Arkansas are hereby authorized and directed to take any and all other necessary and legal steps to carry out this detachment of lands.
