THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY NICK LOWRY TO ACCEPT THEM AS WRITTEN AND IT WAS 2ND BY HAROLD JAMES. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT. A MOTION WAS MADE BY KARL LOWRY AND 2ND BY HAROLD JAMES TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR NONE OPPOSED.

ROAD COMMITTEE: -MAYOR JACK FIELDS INFORMED THE BOARD THE TOWN CEPTIC TANK HAD BEEN MOVED.




NEW BUSINESS:

ORDINANCE NO.02-2023 WAS BROUGHT BEFORE THE BOARD FOR ADOPTING FOR THE TOWN OF FOUNTAIN LAKE, ARKANSAS FOR THE TWELVE (12) MONTHS BEGINNING JANUARY 1, 2024 AND ENDING DECEMBER 31, 2024; APPROPRIATING MONEY FOR EACH AND EVERY ITEM OF EXPENDITURE THEREIN PROVIDED FOR; AND OTHER PURPOSES: WAS READ FOR THE 2ND TIME.

MAYOR JACK FIELDS BROUGHT BEFORE THE BOARD THAT SOME RESIDENCES IN THE NEWLY ATTACHED SUBDIVISION ELK MEADOWS WERE CONCERNED AND UNHAPPY ABOUT THEIR ROADS NOT BEING PAVED IN A TIMELY MANNER AND MAYOR JACK FIELDS INFORMED THEM THAT IT WILL TAKE SOME TIME DUE TO THE HIGH EXPENSE OF THE PROJECT AND PROJECTS THAT THE TOWN ALREADY HAD IN PROGRESS. HE INFORMED THEM THAT THEY COULD DETACH FROM THE TOWN IN HOPES THAT THE COUNTY MIGHT BE ABLE TO PAVE THEIR ROADS QUICKER.

A MOTION WAS MADE BY NICK LOWRY TO ADJOURN AND IT WAS 2ND BY JOSEPH REPICI. ALL WERE IN FAVOR, NONE OPPOSED.
