OLD BUSINESS: THE PLAYGROUND EQUIPMENT WAS DELIVERED TO THE TOWN HALL.





A MOTION WAS MADE BY NICK LOWRY TO SUSPEND THE RULES AND TO DECLARE AN EMERGENCY TO EXIST AND IT WAS 2<sup>ND</sup> BY HAROLD JAMES. ALL WERE IN FAVOR NONE OPPOSED.
