MINUTES FROM THE 239TH TOWN COUNCIL MEETING. THIS WAS HELD ON MAY 12, 2025.

THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS.

MEMBERS PRESENT WERE MAYOR JACK FIELDS BY PHONE, KARL LOWRY, NICK LOWRY AND SHAWNA BOWEN. MEMBERS ABSENT WERE HAROLD JAMES AND JIMMY ATTEBURY. ATTORNEY JUSTIN HURST WAS ALSO ABSENT.

THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY NICK LOWRY TO ACCEPT THEM AS WRITTEN AND IT WAS 2ND BY SHAWNA BOWEN. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT. A MOTION WAS MADE BY KARL LOWRY AND 2ND BY NICK LOWRY TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.

FINANCIAL COMMITTEE: THE AUDITOR STILL HAS THE BOOKS.

ROAD COMMITTEE: NICK STATED OLD STAGECOACH HAS BEEN MOWED.

OLD BUSINESS:

MEDLOCK CEMETERY BIDS WERE DISCUSSED THE BOARD STATED THE ONE FROM TOMMYS ASPHALT WAS THE BETTER DEAL THE MAYOR ASKED FOR A MOTION TO ACCEPT THE TOMMYS ASPHALT BID TO COMPLETE THE JOB. SHAWNA BOWEN MADE A MOTION TO ACCEPT THE BID AND IT WAS 2ND BY KARL LOWRY ALL WERE IN FAVOR NONE OPPOSED.

MAYOR TALKED TO GATE PEOPLE TO COME CHECK THE GATE OUT AT THE TOWN HALL.

SECURITY COMPANY CHECK WAS MAILED.

SIGNS ARE IN THE PROCESS OF BEING MADE FOR ENGINE BRAKING. DISCUSSION WAS MADE WHERE TO PUT THEM, (BY BUTANE PLACE AND CITY LIMIT SIGNS.)

NEW BUSINESS:

DISCUSSION WAS MADE ABOUT PRELIMINARY FINDINGS FROM THE AUDITOR WHO STATED THE TOWNS GENERAL FUND WILL HAVE TO PAY THE STREET FUND BACK FOR THE FUNDS SPENT ON PAVING IN THE GATED COMMUNITY.

A RESOLUTION WILL NEED TO BE BROUGHT BEFORE THE BOARD AUTHORIZING THE REPAYMENT OF STREET FUNDS FROM THE GENERAL FUND REVENUE FOR THE TOWN OF FOUNTAIN LAKE, ARKANSAS AT A RATE OF NOT LESS THEN TEN PERCENT (10 %) OF GENERAL REVENUE:



THAT HE HAD MENTIONED TO THEM THAT THEY OMITTED THE ROAD FROM DEER PARK TO SALINE COUNTY


