THE MEETING WAS CALLED TO ORDER BY MAYOR JACK FIELDS.

MEMBERS PRESENT WERE MAYOR JACK FIELDS BY PHONE, KARL LOWRY, NICK LOWRY AND SHAWNA BOWEN. HAROLD JAMES AND JIMMY ATTEBURY WERE ABSENT. ATTORNEY JUSTIN HURST WAS ALSO PRESENT.

THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY SHAWNA BOWEN TO ACCEPT THEM AS WRITTEN AND IT WAS 2<sup>ND</sup> BY NICK LOWRY. ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT. A MOTION WAS MADE BY KARL LOWRY AND 2<sup>ND</sup> BY SHAWNA BOWEN TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.

GATE LOCKS HAVE BEEN REPLACE WITH NUMBER LOCKS FOR WORKERS.




