THE MINUTES WERE HANDED OUT. A MOTION WAS MADE BY NICK LOWRY TO ACCEPT THEM AS WRITTEN AND IT WAS 2ND BY HAROLD JAMES ALL WERE IN FAVOR NONE OPPOSED.

THE FINANCIAL TOTALS WERE GIVEN OUT. A MOTION WAS MADE BY KARL LOWRY AND 2ND BY SHAWNA BOWEN TO ACCEPT THEM AS WRITTEN. ALL WERE IN FAVOR. NONE OPPOSED.

FINANCIAL COMMITTEE: THE CLERK/TREASURER STATED AFTER REVIEWING TO PREPARE THE 6 MONTHS AND YEARLY SHE FOUND THAT JAN. 1, 2025 TO JUNE 30, 2025 WAS NOT COMPLETED DUE TO THE AUDITOR HAVING BOOKS AND IT WAS NOT COMPLETED WHEN THEY WERE RETURNED. SO, I AM HANDING OUT THE FINANCIALS FOR THE WHOLE YEAR FROM JAN. 1, 2025 TO JUNE 30, 2025, FROM JULY 1, 2025 TO DEC. 31, 2025 AND FROM JAN. 1, 2025 TO DEC. 31, 2025. 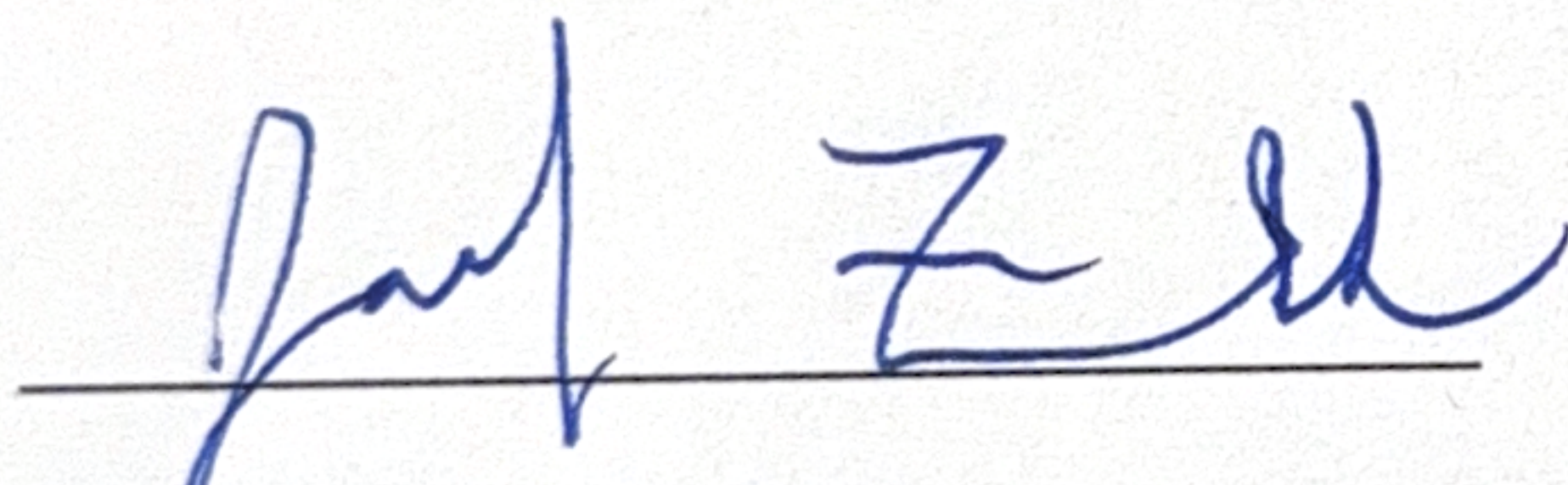
ROAD COMMITTEE: TIM JACKSON CLEARED ALL THE TOWN STREETS AFTER THE ICE STORM.

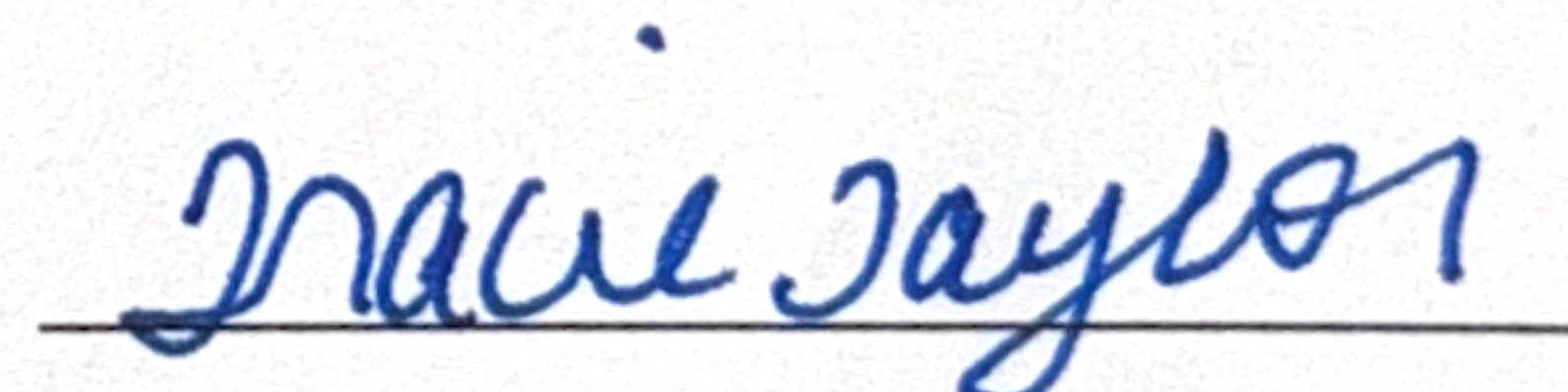
