FINANCIAL COMMITTEE: AUDITOR STILL HAS BOOKS

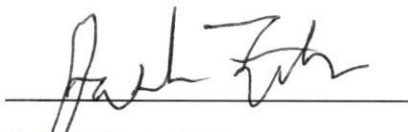
ROAD COMMITTEE: NONE

NEW BUSINESS: ORDINANCE 01-2026 TO AMEND ORDINANCE 2014-02 AND TO PROVIDE FOR AN AMENDED SECTION 1.01.04 CONDITIONS. AMENDING THE COST-OF-SERVICE LIMIT FOR ELECTED OFFICIALS AND IMMEDIATE FAMILY MEMBERS AND TOWN EMPLOYEES: WAS READ FOR A THIRD TIME. A MOTION WAS MADE BY HAROLD JAMES AND 2ND BY NICK LOWRY TO ACCEPT THE ORDINANCE. ALL WERE IN FAVOR NONE OPPOSED.
